## OVERBILL ADDENDUM TO DEALER PRODUCER AGREEMENT

---

The following Overbill “Addendum” is part of the DEALER PRODUCER AGREEMENT (hereinafter referred to as the “AGREEMENT”) executed between American Auto Shield, LLC (hereinafter referred to as “AAS”) and Dealer Producer (hereinafter referred to as “DP”) \_\_\_\_\_.

This ADDENDUM is effective on the date listed in the signature section below.

### 1. OVERBILL

DP requests that AAS add the total amount of overbill commissions as set forth below to the net DP cost for each contract sold by DP and DP agrees to remit said amounts as the net DP costs in accordance with the DEALER PRODUCER AGREEMENT.

### 2. PAYMENTS

For each Vehicle Service Contract sold by DP for which full payment, including overbill amounts, has been received by AAS, AAS agrees to compensate the Payees the commission rate (hereinafter referred to as the “COMMISSION”) amounts listed in the Overbill Payee tables below.

### 3. DP AGREES THAT:

- a. No COMMISSIONS or other payments shall be deducted from payments due to AAS.
- b. If any Vehicle Service Contract is cancelled for any reason , whether during or after the term of this ADDENDUM, DP shall remit to AAS the pro-rata portion of COMMISSIONS paid to Payee(s) for such Vehicle Service Contracts within thirty (30) days of receipt of invoice from AAS. Alternatively, AAS may deduct such pro-rata portions from future COMMISSIONS. The obligations of Payee(s) contained in this section shall survive any termination of this ADDENDUM or termination of the DEALER PRODUCER AGREEMENT.
- c. COMMISSIONS due to PAYEE(S) are limited to those amounts outlined in the Overbill Payee tables.
